By signing this agreement, the Producer/Applicant acknowledges and agrees to the following terms:

1. **Application and Approval:** The Producer/Applicant shall contact **Diamond Tooth Gerties** a minimum of 14 days prior to the requested shooting date to obtain this release. A completed and signed copy of this release is required 7 days prior to shooting.
2. **Purpose of Recording:** The footage/images captured will be used for the listed project as indicated under "Project/Use".
3. **Usage Rights:** The Producer/Applicant shall ensure that any media captured complies with the legal rights of any individuals appearing in the footage/images, including obtaining necessary model releases.
4. **Restrictions:**
 - No footage or images shall be used in a manner that negatively impacts the reputation of **Diamond Tooth Gerties**.
 - Any areas restricted from filming will be communicated prior to the shoot and must be respected.
 - The use of drones or specialized equipment requires prior written approval.
5. **Liability:** The Producer/Applicant agrees to take full responsibility for any damages, injuries, or disruptions caused during the media capture process.
6. **Media Code of Conduct:** Our goal is to ensure media get the opportunity to capture our venue in the most positive light; however, we also have to ensure that our players and staff members are not affected negatively during your visit. Below are ways you can help ensure a positive experience at our venue:
 - All media should contact us as soon as possible to discuss their plans within the venue.
 - Upon arrival, present yourself at the front wicket and connect with a manager to go over your plans.
 - Do not block the view of paying customers during the can-can shows.
 - Do not take explicit pictures of players at tables or slots without their consent (ambiguous photos are acceptable).
 - Treat all players and staff with respect.

- Avoid use of flash photography.
- Share your work with us following completion.

7. Attribution: If required, credit should be given to **Diamond Tooth Gerties** in any public-facing media.

8. Final Authority: Diamond Tooth Gerties reserves the right of final authority in case of interpretation, exceptions, limitations, or any other matters related to this agreement.

9. Revocation of Permission: The venue reserves the right to revoke this authorization at any time if the terms of this agreement are violated.
